Transportation Service Agreement

This agreement is entered into on the 31st day of January, 2024 by and between Bucyrus City Schools located at 170 Plymouth Street Bucyrus, OH, and Ohio Specialty Services, LTD. located at 1825 East Mansfield Street, Bucyrus, OH.

Whereas, both parties desire to enter this agreement to have transportation services provided for Phoenix D. attending LEAP, THEREFORE, the parties mutually agree to the following:

1.) PURPOSE

It shall be the responsibility of the Transportation Provider (Ohio Specialty Services, LTD.) to provide transportation for children from their place of residence.

The paramount responsibility of Ohio Specialty Services, LTD. shall be to assure the safety and well-being of those children being transported

2.) DESCRIPTION OF SERVICE

- A.) All services provided by OSS shall be in accordance with all laws and regulations of the Ohio Department of Education, and all other applicable state and federal laws and regulations governing transportation services to children.
- B.) OSS shall maintain access to additional vehicles as may be necessary to assure transportation is covered on each day of program operation in a safe and timely fashion.
- C.) OSS shall be responsible to appropriately maintain and service each vehicle used.
- D.) No individual transported shall be scheduled to ride more than ninety minutes one way.
- E.) Attendance will be taken on a daily basis by drivers. The attendance records will be sent to Bucyrus City Schools by the end of each month.

3.) DURATION

This agreement shall be in force for the 2023-2024 school year.

If OSS desires to no longer provide transportation services to Bucyrus City Schools, such notices must be given in writing 3 months prior to the date on which these services are to be discontinued.

4.) COST

Compensation shall be at \$1,100 per month, running a daily morning and afternoon route.

5.) GOVERNING LAW

All conditions are made and may be performed in part in the State of Ohio, and the various terms, provisions, covenant and agreements, and the performance thereof, shall be construed, enforced and determined under and with reference to the laws of the State of Ohio. If any one or more covenants, agreements, terms and provisions herein contained shall be held contrary to the policy of express law, or against public policy, or shall for any reason whatsoever be held invalid or unenforceable, then any such covenants, agreement, terms and provisions of this agreement and such holding shall in no way affect the validity or enforceability of any of the other covenants, agreements, terms and provisions hereof.
