SPEECH THERAPY SERVICES AGREEMENT

This agreement, made and entered into at Bucyrus, Ohio, this _____, 2022, by and between Mohican Rehabilitation Services, LLC ("MRS") of Bucyrus, and Bucyrus City Schools;

WHEREAS, Mohican Rehabilitation Services, LLC operates a Speech Therapy (SLP) Department providing services to patients by licensed Speech Therapists;

AND WHEREAS, Bucyrus City Schools desire the professional services of Speech Therapy;

NOW THEREFORE, in consideration of the mutual promises contained herein, MRS and Bucyrus City Schools hereby agree as follows:

1. Bucyrus City Schools hereby engages MRS to provide professional Speech Therapy services to its students/patients.
2. During the term of this agreement, Bucyrus City Schools will make available reasonable Speech facilities for the provision of services.
3. Mohican Rehabilitation Services, LLC will comply with the requirements of 45 CFR 164.504 (e)(1) for safeguarding and limiting access to information concerning beneficiaries.
4. Mohican Rehabilitation Services, LLC will allow representatives for the US Department of Human Services, ODM, ODE, or their respective designee access to the subcontractor's books, documents and records.
5. Mohican Rehabilitation Services, LLC acknowledges that they or their principles are not suspended or disbarred.
6. MRS agrees that SLP services will be provided in a professional manner in accordance with the laws governing the practice of SLP in the State of Ohio.
7. MRS shall provide SLP evaluations of and services to students of Bucyrus City Schools.
8. MRS shall conform to all applicable Bucyrus City Schools' policies concerning documentation.
9. MRS shall prepare documentation that includes the care given, instruction and assessments made. Such documentation shall be incorporated in to the student's record within five (5) days after rendering the service.

10. MRS's compensation for said services shall be \$75.00 per hour for Speech therapy services. MRS reserves the right of first refusal. Billable time to Bucyrus City Schools includes direct treatments, documentation, meetings regarding patients, and travel from portal to portal, at the rate of \$0.585 per mile. Services will be billed on a monthly basis and is payable within fifteen (15) days of Bucyrus City Schools receipt of the billing statement.
11. This Agreement becomes effective August 1, 2022. It shall continue in effect for 3 years (3) years from such date. This Agreement shall automatically renew for an additional thirty-six (36) months unless otherwise terminated by either party, notice must be given 90 days prior to contract renewal date.
12. Bucyrus City Schools shall not directly or indirectly employ, contract with, or otherwise engage the professional services of the employees or staff of MRS during the duration of this agreement and for twelve (12) consecutive months following termination of this agreement.
